2. An Expert Team conducted onsite evaluation of the programs from 14th to 16th July, 2023. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted accreditation for 3 years. **K. L. N. College of Engineering, Madurai-Nedunkulam Road, Pottapalayam- 630 611, Sivagangai District, Tamil Nadu** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **K. L. N.
